- Due to the high number of entries, the entries for voting will appear in a random order on multiple pages (every entry will not all appear on the first page). You must click through them all in order to find yours. Your photo may not always appear in the same spot within the page, because they are loaded in a random order each time the page is opened.
- When voting, please be sure to view all the entries, so that you don't miss out on any of the unique and talented entries!
